

German-Macedonian Business Cooperation

For a quarter of a century, AHK North Macedonia and the DMWV have played a key role in the successful development of German-Macedonian economic relations through their ongoing activities.

- **Currently, over 200 German companies** are operating in North Macedonia. German investments in the country span diverse sectors, including the production of high-quality components for the automotive industry, train and bus seating, medical equipment, specialized workwear, and household electronics. Additionally, German service providers are present in areas such as technology, logistics, education, and healthcare.
- **German investments** provide approximately **28,000 jobs** across North Macedonia.
- **The vocational training program** since 2018 has trained over **750 high school students** as mechatronics technicians and production mechanics through the dual system, in accordance with German standards.
- **Trade** between the two countries has increased by approximately **800**% since 2000, with North Macedonia now maintaining a positive trade surplus with Germany.
- **Exports** to Germany have increased by more than **tenfold** in the same period. **Almost half of the Macedonian** total export goes to Germany today, produced by German investors in North Macedonia and the local suppliers for the German industry and retail sectors.
